## **ESRC Government Forum on Research Methods**

## 28 October 2004, at The Royal Society, London

## **Summary of Discussion**

Participants at the forum came from a wide range of government departments as well as the National Centre for Research Methods (NCRM), the Research Methods Programme (RMP) and ESRC. The meeting sought to identify needs relating to research, training and capacity building in research methods as well as to identify opportunities to address these needs via engagement and co-operation between government and NCRM (and academia more generally).
